Fintraffic Sky Terms of Use

End User License Agreement / Consent to the Collection and Use of Your Data

Before using the software, please read this End User License Agreement ("License") carefully. By using the software, you agree to the terms of this License. If you do not agree to the terms of this License, no agreement permitting use is formed, and you may not use the software.

You agree that Fintraffic Air Navigation Services Ltd may collect and temporarily store personal data obtained through the Software, specifically your name, email address, and phone number, aircraft call sign, open field entry, and the above-mentioned device location data. The purpose of collecting this data is to enable actions required by submitted reports. You agree that your aircraft call sign, name, and phone number may be displayed to other pilots, with the aim of enhancing aviation safety. The collected data will be retained in accordance with the data protection principles of Air Navigation Services.

Changes to the Software

Changes to the Software may alter the scope of personal or other data collected, stored, or transmitted through the Software, as well as the selection of authorities or other entities to whom the necessary data may be transmitted on a case-by-case basis.
